The Composite Research Group, Durban University of Technology (hereafter referred to as **CRG, DUT**) and BGS- Institute of Technology, Department of Nanotechnology, Adichunchanagiri University, B.G. Nagara-571448, Karnataka, India (here after referred as **BGSIT, ACU**).

Believing the extension and strengthening Scientific exchange and co-operation to be of mutual value to their university/institute (hereafter referred to as institution) and to the development of understanding between our peoples, hereby record their agreements to promote academic, research and educational exchange between their institutions through the following activities.

Background:

CRG, DUT and BGSIT, ACU are planning to collaborate in formal way. Professor K Kanny, Director of, Composite Research Group (CRG), Durban University of Technology, South Africa and Prof. K. Byrappa, Pro. Vice Chancellor and Dean, Research of Adichunchanagiri University have met recently in South Africa during November 2018. Both have discussed in detail to come out with a collaborative research in the area of Advanced Functional Nano materials and Composites.

## **1. AREA & METHOD OF COOPERATION**

### **L1 FACULTY & STAFF EXCHANGE**

#### **Exchange of Academic Staff**

CRG, DUT Durban and BGSIT, ACU India may nominate their academic staff to participate in an exchange for the purpose of study or lecturing in the other institution on a reciprocal basis. The participant is subject to approval by the host institution. The period of exchange will normally be one or two semesters. The host institution will provide a university visiting appointment, library, research facilities, and other assistance such as local hospitality and conveyance. The sending institution will also maintain its academic staff on full salary during the period of the exchange. The host institution will assist the visiting academic staff in locating living accommodation.

#### **Visiting Academic Staff**

In addition to the reciprocal exchanges, either institution may invite faculty members of the other institution for the purpose of lecturing or consultation, and/or research guidance for a specified period of time, subject to the approval of the home institution. In such cases the inviting institution makes appropriate funding arrangements agreed to in advance.

#### **Visiting Research Fellows**

Either institution may nominate one or more of its faculty to visit the other institution for the purpose of advanced study or research, subject to the approval of the host institution. In such cases, the sending university will provide the Research Fellow with normal salary/fellowship based on the sending institution's regulations. The institution will provide institutional courtesies, library and research facilities as per the terms and conditions applicable at Durban University of Technology and BGSIT, ACU, India.

### **L2 STUDENT EXCHANGE**

#### **Exchange of students**

Each institution may send students, either Undergraduate or Postgraduate, including Master's and PhD to the other institution in appropriate fields of study.

Both institutions agree that the exchange program for degree training should follow the educational system and regulations of the counterpart institution. Students must submit their applications to the other college or faculty through their own institution.

Should both institutions agree to exchange students, a separate student exchange agreement will be developed to formalise this aspect of the collaborative arrangement.



### 1.3 COOPERATIVE RESEARCH

Co-operative research is to be encouraged as individual scholars or departments establish contact and develop mutual interests. The cost and conditions of such agreements will be covered by the home institution of the academic staff.

### 1.4 EXCHANGE OF ACADEMIC MATERIALS

Each institution may exchange relevant materials, such as those relating to the library. The libraries can also exchange reference materials for research purposes.

## 2. CO-ORDINATION OF THE EXCHANGE

Each institution shall designate a lead coordinator to develop and co-ordinate the specific activities agreed upon including collaborative conferences and workshops and/or working groups.

and the members of the team shall be the active faculty from related fields working at BGSIT, ACU

## 3. PRINCIPLES

The CRG, DUT and the BGSIT, ACU will each accept the participants selected by the other party if mutually acceptable academic and/or professional qualifications and standards are met. All participants will be treated in the same non-discriminatory manner in carrying out the provisions of the Memorandum of Agreement (MOA), subject to the provisions of the policies and requirements of each of the institutions. Any violation of these Principles will be considered grounds for terminating this MOA. Implementation of this MOA at the Durban University of Technology will be in accordance with the Durban University of Technology's Policy on International Cooperation. This policy states that participants under this MOA will be selected on the basis of merit without regard to race, national or ethnic origin, colour, religion, age, sex, sexual orientation, marital status or physical handicap. Similarly, implementation of this MOA at BGSIT, ACU, India in accordance with the rules and regulations applicable in that institution.

## 4. TERMS OF COOPERATION

The terms of co-operation for each specific activity implemented under this Memorandum of Agreement shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity. Any such agreement entered into, as outlined above, will form an Appendix to this Memorandum of Agreement.

***Length of Agreement***

This Letter of Intent will remain in force for a period of five years subject to the availability of funds and adherence to the terms of cooperation.

***Accountability***

An annual activity report shall be submitted and by the lead coordinators to each of the institutions designated representatives.

***Amendments***

Any amendment and/or modification of the letter of Intent will require written approval of each of the chief signing officer of each contracting institution and shall be appended hereto. After the initial three year period this letter of Intent may be renewed by mutual consent for another 5 years. For this purpose, the responsible parties will be the Dean, Faculty of Engineering, Durban University of Technology and the Vice Chancellor, Adichunchanagiri University.

***Termination***

Either party reserves the right to terminate this Letter of Intent upon six months written notice. Any program or activity that has already commenced shall be completed to the best of both parties' abilities.

Two signed originals of this Letter of Intent will be produced, one to reside with each party.





### **Memorandum of Understanding**

This Memorandum of Understanding is made as of the 1<sup>st</sup> day of July, 2021,

**BETWEEN:**

**DEBRE BERHAN UNIVERSITY**

**DEBRE BERHAN, ETHIOPIA**

And

**ADICHUNCHANAGIRI UNIVERSITY**

**B.G. NAGARA, NAGAMANGALA (TQ)., MANDYA DISTRICT, KARNATAKA INDIA**

(Individually a "party" and collectively the "parties")

The College of Engineering, Department of Mechanical Engineering, represented by Debre Berhan University and the Department of Mechanical, represented by Adichunchanagiri University wish to establish relations between the two parties to stimulate and facilitate the development of collaborative and mutually beneficial programs which will foster the intellectual life and cultural development on both campuses and international cooperation. Therefore, through this Memorandum of Understanding (MOU) the parties agree to pursue academic and research collaboration in support of their mutual interests.

1. Exchange of faculty/academic staff members for the purpose of research, teaching and the presentation of special courses in their fields of specialization;
  - Student exchange and study abroad programs;
  - Establishment of joint research programs;
  - Collaboration on third-party funded educational or economic assistance activities;
  - Exchange of postgraduate students in respect to specific research projects or courses of interest and importance;

- Exchange of scientific and educational literature produced by either or both parties, as well as the exchange of materials on the most relevant and topical research by researchers at both Debre Berhan University and Adichunchanagiri University ; and
  - Organization of conferences, seminars and symposia of mutual interest to the institutions.
2. Details of the implementation of any particular exchange resulting from this MOU shall be negotiated between the two parties and agreed upon in writing by both parties prior to the initiation of that activity.
  3. Each activity is to be governed by terms and conditions separately negotiated by the parties and subject to the written agreement of the parties through an exchange of letters or the signing of a separate joint agreement.
  4. Renewal, Revision, Cancellation and Notices
    - a. This MOU is effective for five (5) years, commencing on the date first written above and expiring on July 30, 2026.
    - b. This MOU will be renewed after five (5) years upon written consent by both parties.
    - c. Either party may cancel this MOU at any time by either party providing six (6) months written notice to the other party of its intention to do so. Termination of this Agreement will not affect any projects or programs in progress under a separately negotiated agreement at the time of termination will remain unaffected
    - d. Any amendments or modification of the present text shall be submitted for review to the competent authorities and shall not be binding unless except as agreed in writing and signed by both parties.
  5. Each party shall require visiting students and scholars to secure their own accommodation during the visit period; however the receiving party shall provide information and support in making accommodation arrangements.
  6. Each party shall pay its own costs, expenses, risks, or liabilities arising out of the implementation of this MOU.
  7. Both parties will try to seek external funding sources to facilitate exchange programs and joint research activities.
  8. Each party is an independent contractor and has no authority to represent or bind the other party.
  9. Neither party may assign this MOU without the prior written consent of the other party.


10. This MOU is binding upon and ensures to the parties and their respective successors and permitted assigns.


11. This MOU may be executed simultaneously in two or more counterparts each of which shall be deemed an original, and all of which, when taken together, constitute one and the same document. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or electronic transmission shall be effective as delivery of a manually executed counterpart.

## ACU-APCOGSYS- MoU

This MEMORANDUM OF UNDERSTANDING (hereinafter called 'MoU') on Collaboration between Adichunchanagiri University (ACU), having its principal office at NH-75, B.G. Nagara -571448, Nagamangala Taluk, Mandya District, Karnataka, India (hereinafter referred to as the 'ACU' or 'First Party').

And

APPLIED COGNITION SYSTEMS Pvt. Ltd, a company established and existing under the laws of The Republic of India, with its registered office at #1362, Bhuvaneshwari Complex, Jayanagar 9th Block, Near East End Circle, Bangalore - 560069, India (hereinafter referred to as 'APCOGSYS' or 'Second Party', collectively referred to herein as the 'Parties').

WHEREAS the Parties recognize the value of cooperation and have agreed to continue their common interest in promoting the mutual cooperation in the area of training in education & research;

AND THUS the Parties have agreed to set forth their mutual understanding formally by way of this MOU as per terms and conditions mentioned hereunder

### TERMS AND CONDITIONS:

1. The scope of the collaboration under this MOU shall include Training, education & Research activities. The activities shall be pursued under specific programs mutually agreed to and revised from time to time.
2. The activities will be carried out either at ACU premises or at APCOGSYS premises as per needs of specific programs.





3. Conduct workshops/certification courses (single day to one month) in specialized topics to enable students with industry relevant skills beyond the academic syllabus. Such workshops/courses are optional for students and may be awarded credit points as part of practical training as per their UG/PG academic requirements. Such workshops may also be thrown open by the university for candidates from other colleges and industry professionals.
4. Provide Internship projects for industry experience for students of ACU. APCOGSYS shall provide internship certificate to such candidates upon successful completion of internship projects based on its evaluation
5. Conduct Joint Research projects with grants from external funding agencies to cover budgets on a project to project basis to and publish outcomes with co-authorship of enrolled students and staff of both parties.

**APCOGSYS responsibilities:**

- a) Provide syllabus, teaching content and experts to teach and train for all of its courses at its own cost.
- b) Provide experts to jointly form proposals, conduct research and publications thereof.
- c) Provide its health-care/technology software platforms for training students enrolled in specific courses.
- d) Source internship opportunities to students selected by performance assessment in its courses.
- e) For short term/certification courses and workshops APCOGSYS shall collect a mutually agreed fee, retain 85% of the revenue and pay the balance amount to ACU

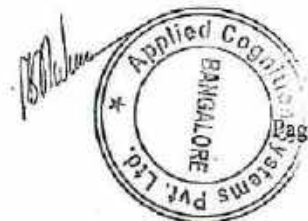
**ACU responsibilities:**

- a) ACU shall provide joint certification with APCOGSYS for the workshop/short term/certification courses conducted by APCOGSYS.





- b) Advertise the collaboration programs inside the institution and to external institutions as found appropriate by both parties to enroll students for each course.
- c) ACU shall collect payments from agencies granting research funds and shall transfer APCOGSYS's portion of the funds as per budget plan mutually agreed between the parties and approved by the grant agency. All payment transfers shall include applicable taxes.
6. APCOGSYS shall have sole, full and absolute rights over all forms of intellectual property it may share with ACU staff and students during the course. ACU staff and students will be bound by this agreement to not share confidential information and intellectual property of APCOGSYS to anyone without written permission of APCOGSYS.
7. CONFIDENTIAL INFORMATION disclosed by the Disclosing Party shall mean any nonpublic information (including information embodied in samples) related to projects given by the disclosing party to the receiving party covering, design and development and testing of Mechanisms and related Software and the required electronics. CONFIDENTIAL INFORMATION shall include information provided in documented form explicitly marked/notified as confidential and crucial information communicated orally or/and documented in minutes of meeting as confidential disclosure.
8. The receiving Party will not have any obligation or liability for any portion of the CONFIDENTIAL INFORMATION that:
- The Receiving Party can demonstrate that it was previously known to it;
  - Is, or becomes, available to the public through no fault of the Receiving Party;
  - Is lawfully obtained by the Receiving Party from a third party, without breach of any obligation to the Disclosing Party;
  - Is independently developed by or for the Receiving Party independent of any discloser hereunder; or
  - Is required to be disclosed pursuant to proper governmental or judicial process, provided that notice of such is promptly provided to Disclosing Party in order that





Disclosing Party may have every reasonable opportunity to intervene in such process to contest such disclosure.

- f. Confidential Information of a third party that is given to the receiving party by the disclosing party without any explicit notification that it is confidential

If any portion of Disclosing Party's CONFIDENTIAL INFORMATION falls within any of the above exceptions, the remainder shall continue to be subject to the terms of this Agreement.

9. Either party shall not directly/indirectly engage in any activities that may result in poaching of each other's staff members or damage the reputation of the other's organization.
10. SETTLEMENTS OF DIFFERENCES OF OPINION AND INTERPRETATION: Any differences of opinion and interpretations of this MOU shall be settled by mutual consultation or negotiation between the parties
11. SEVERANCE: If any part of this MoU is or becomes void, voidable or otherwise invalid or unenforceable, whether due to the provisions of any statute or otherwise, that part:
- Will be read so as to be valid and enforceable, if possible; OR
  - Will be severed from this MOU to the extent that the remaining parts will remain in full force and effect.
12. NO AGENCY: Nothing in this MoU shall create an agent, partner or representative relationship to any other party. No Party has the authority to assume, create or incur liability of any kind in the name of, or on behalf of, the other party except as may be otherwise expressly stated herein.
13. AMENDMENTS, DURATION AND TERMINATION
14. Any amendments to this MoU can only be made in writing and with mutual written consent of the two parties. Such amendments, once approved by both institutions, will become part of this MOU and are incorporated by reference;
15. The effective date of this MoU shall be the date on which this MOU is signed by both parties.






16. This MoU shall be in force for a period of 3 years from the date of the last signature, extendable by mutual written consent.

Either party shall assign one person to coordinate day-to-day interactions of various activities under this MOU. Authorized representatives of APCOGSYS and ACU shall sign two original MOU documents and each party shall hold one original signed MoU, with both documents being equally authentic.


