#### Memorandum of Understanding (MoU)

This Memorandum of Understanding ('MoU') is made and executed on this **Two Day of July Two Thousand Twenty One** by and between: **Department of Pharmacy Practice**, Sri **Adichunchanagiri College of Pharmacy**, **Adichunchanagiri University**, **B.G.Nagara**, through its authorized signatory by **Dr.B.Ramesh**. Dean of Faculty of Pharmacy & Principal herein referred to as "**SACCP**", which in expression shall unless it is repugnant to the context or meaning thereof, shall deem to mean and include its successors and assign of the First Part.

ASTER MIMS (Malabar Institute of Medical Science) Kerala, Calicut, a NABH Accredited, 950 bedded Tertiary Care Super Speciality Hospital, Calicut, Kerala- 673016 represented by its Chief Medical Services, Dr. Abraham Mammen, herein referred to as 'ASTER MIMS' of the Second Part.

SACCP and ASTER MIMS shall herein after be collectively referred to as 'Parties' and individually as a 'Party'.

### **PURPOSE/ OBJECTIVE**

The primary purpose of this MoU is to build academic research capacity and to promote mutual understanding between the Parties. The MoU shall formally set out the terms of co-operative relationship between the parties, establish their respective roles and facilitate the function of each party in relation to collaborative research.

Both Parties agree to develop collaborative activities in academic areas of mutual interest and as equal partners with reciprocity. All educational events are expected to reflect the faculty member's area of research and expertise.

The development and implementation of specific activities based on this MoU shall be negotiated and agreed between Parties through the Deans or Head of Department.

This MoU is agreed on the basis of cooperation between the Parties and includes, but is not limited to the following options.

- a. Exchange of faculty members and research scholars between the Parties.
- b. Exchange of students based on the projects and training.
- c. Jointly apply for research funds to conduct collaborative research projects.
  - d: Conducting joint workshop/ conference.
  - e. Exchange of academic/ research information and related materials to facilitate joint publications by collaborating faculty members.
  - f. Promoting any related academic activities based on mutual agreement.
  - g. Development of suitable curriculum/ education module useful for both the Parties.

## TERMS OF AGREEMENT

Both Parties agree to carry out the above mentioned activities in accordance with laws and regulations of respective countries after full consultation and approvals.

The term of this agreement shall be valid for a period of the Five Years commencing from the date of signature hereof. This agreement can be extended for further terms on mutual agreement. This agreement may be terminated by giving 6 months prior notice from either
