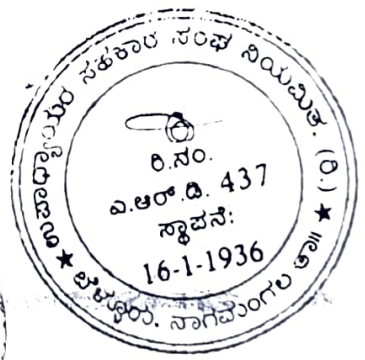
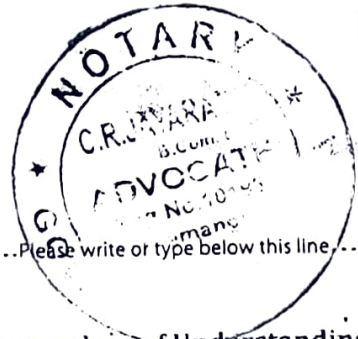

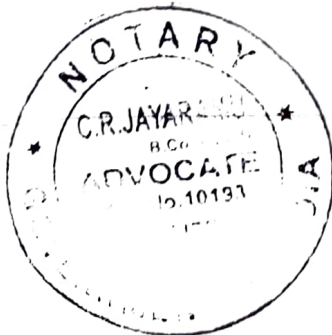
WHEREAS hospital is carrying on Health Services in Health Sector, which may inter alia, provide for health service to patients of the society.

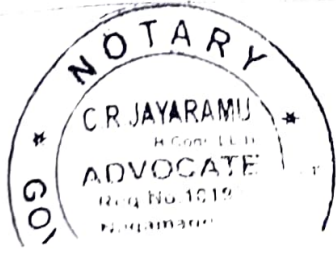
