

4. **Karnataka State Council for Science and Technology (KSCST)** may depute qualified officers/ Individuals to sensitize and train the faculties, students and research bodies of Adichunchanagiri University, in order to create an ecosystem that stimulates innovation and independent thinking among them to evolve innovative ideas for developing value added products, process or services.
5. The MOU between **Karnataka State Council for Science and Technology (KSCST)** and **Adichunchanagiri University, B G Nagara** shall be supplemented by detailed work plans to be developed jointly which

7. Such details agreed upon will be effective by exchange of letters by the **Karnataka State Council for Science and Technology (KSCST)** and **Adichunchanagiri University, B G Nagara** and such letters shall form part of this agreement.

SCOPE OF THE MOU:


