

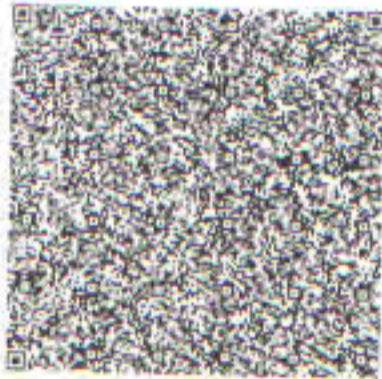

## Purpose

The purpose of this Agreement is to promote technical skills, Industrial training, education and scientific research between the students of Sri Adichunchanagiri college of Pharmacy, BG Nagara and Pharma Training Institute, Bangalore

## Types of Cooperation

Through this memorandum, both Parties affirm the value of collaboration and agree to promote the following activities

1. Joint training programs for students as well as faculty in the field of mutual interest
2. Industrial visits and guest lectures by experts
3. Placement of the deserved candidates
4. Special training for the students as per the industrial requirement
5. Any other activities as mutually agreed

This Agreement places no financial obligations or supplementary funding commitments on either Party. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

Professor **Dr. B Ramesh** of the Sri Adichunchanagiri College of pharmacy will serve as the primary liaison between the two institutions to facilitate the development of future activities.

## Terms

This agreement will become effective upon the date of signature by both Parties. It shall remain valid for a period of five (5) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both Parties. This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days. The agreement may be extended by mutual consent of the two Parties after the five-year period, and it must be renewed in writing.

This Memorandum of Understanding completed in English is hereby signed in two (2) copies with one (1) copy remaining in the possession of each institution.
