



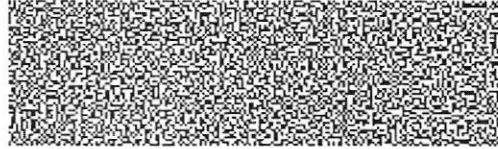





1. DEFINITIONS:

1.1 "Agreement":

Shall mean the Agreement For Providing Medical Benefits in its entirety, including all annexure, schedules and documents referred in this Agreement.

1.2 "Commencement Date":

Shall have the meaning assigned to it in the Preamble of this Agreement.

1.3 "Corporation":

Shall mean the Employees State Insurance Corporation (ESIC)

1.5. "Insured Person":

Shall mean a person who is or was an employee in respect of whom contributions are or were payable under this Act and who are by reason thereof, entitled to medical benefits provided by the First Party under the ESI Act.

1.6. "Modified Employer's Utilization Dispensary":

Shall mean a dispensary made for the insured persons and their families by the First Party made under Section 59A of the ESI Act, 1948 in lieu of State Government for medical arrangement and for which the Second Party has expressed its willingness to operate and run the Modified EUD.

1.7. "Party":



1.8. "Parties":


Shall have the meaning assigned to it in the Preamble of this Agreement.

2. TERM OF THE AGREEMENT:

2.1 This Agreement shall come into force w.e.f. **01.12.2022** and shall be valid for a period of **one year** and thereafter the same shall be renewed as per mutual written agreement between the Parties, unless terminated by either of the Parties in terms of Clause 12 of this Agreement.

3. ESTABLISHMENT:

3.1. The first party shall pay a capitation fee @ of Rs. 400/- per Insured Person family unit per annum to the second Party for running the Modified EUD and Second Party shall spend the receipted amount for paying remuneration to the staff deployed in the Modified EUD, running cost and managing the affairs.


3.2 The First party shall pay Capitation Fee in advance for approved total number of attached and eligible insured persons to the dispensary (Modified EUD) to the Second Party on quarterly basis and subject to verification of the online update of registration of the Insured Persons on monthly basis, medical Stock etc which will be carried out by the First Party.


3.3 Funds from ESIC will be transferred directly to the account which is already opened in the name of "ESI SAVING FUNDA/C NO 2-MEUD B G NAGAR" for the said dispensary and First Party has already given access to the Second Party for operational purpose.

3.4 The Second Party shall submit the utilization certificate and expenditure statement (Annexure – A) of the amount of preceding quarter of capitation fees before the release of advance money for the next quarter. Expenditure statement may be furnished as per records, maintained for the purpose.

3.5 The First Party will adjust the total amount in the last quarter of financial year as per actual expenditure (based on certified expenditure statement and utilization certificate) or as per ceiling of Rs.400/- per IP family unit per year, whichever is less.

3.6 The First Party shall authorize the Second Party to issue Regulation Certificate to the Insured Person for cash benefit. The doctor of modified EUD may refer the patient/entitled beneficiaries for Secondary Care services to the nearest ESIC/ESIS Hospital within the 25 KM of radius (catchment area). However if there is no ESIC/ESIS hospital in the catchment area then he may refer the patient through online approval of ESIC Medical Officers of nearest Dispensary cum Branch Office/Medical Referee/State Medical Officer to other public or private Hospitals which have a tie up by the Corporation and the Second Party shall also maintain the record of referrals with valid reasons. Second Party shall also provide these records to the First Party as and when required.

4. SERVICES PROVIDED & MAINTENANCE:

The First Party shall provide the following services in connection with the creation and operation of the Modified EUD.


4.1. That First Party shall provide medical and surgical equipments and drugs and dressing materials as per Annexure "B" and "C" through State Medical Officer, Karnataka and shall replace and replenish the same on a demand from the Officer-in-charge of dispensary appointed by the Second Party from the nearest dispensary/hospital/ESIC medical store controlled by the First Party as per the requirement or utilization in the Modified EUD.


4.2. The First Party has already provided a rented building with required fittings and fixtures in consultation with the Second Party and First party shall continue to pay the rent for the building and the Second Party shall maintain it properly within the ceiling amount agreed by both the Parties. At the expiry of the agreement, second party will handover the building back to the first party.

4.3. The Second Party shall maintain the building/premises as per terms and conditions as per the Rent Agreement. The second party will abide by the terms and conditions of Rent Agreement between first party and landlord of the rented building. Copy of the rent agreement is enclosed

4.4 The First Party has already provided furniture, dispensary equipments, computers, printers, telephone and internet connectivity etc. as per Annexure 'D' and the same shall be properly maintained by the Second Party and if any repairing or service or maintenance is required for any damage the Second Party shall be liable to procure, repair or maintain the same. However, the consumables shall be provided by the Second Party.

4.5 The Second party shall bear all the expenditures incurred on account of recurring cost on civic, IT support facilities, telephone & internet connectivity and maintenance of equipments.

4.6 The ownership of furniture, dispensary equipments, computers and other items etc provided by the first party will continue to vest with the first party and second party will handover the same including drugs and dressings in the stock to the first party at the expiry of term of agreement. List of inventory is enclosed

5. APPOINTMENT OF MEDICAL STAFF(S) & PROFESSIONALS:

5.1 The Second Party shall appoint qualified medical/para-medical personnel as per Annexure "E" and the First Party shall not interfere and be responsible for such appointment/engagement of them for running Modified EUD. "The First party will not entertain any claim in any manner from the staff engaged by the Second party and staff so deployed will be on exclusive roll and responsibility".

5.2 The Second Party shall appoint an officer-in-charge of the Dispensary/Dispensary-in-charge to look after the day to day functioning and maintenance of the Modified EUD.

5.3 The Second Party shall inform the First Party the details of Doctors and other manpower for providing them user ID and password to access ESIC Health Information System (HIS – Dhanwantri Module).

5.4 No benefit/ any kind of compensation shall be directly or indirectly claimed by the medical staff/ doctors/technicians from the First Party.

6. WORKING HOURS:

6.1 The second party shall ensure and supervise that the Modified EUD shall be operable for at least six hours a day and six days in a week.

6.2 The Officer-in-charge of the Modified EUD shall determine the number of extended operable hours of the Modified EUD, if and when the requirement arises.

7. SUPERVISION:

7.1 The Second Party shall ensure the keeping of record of patients, stock of medicines and other services provided in the Modified EUD like tests and medical examinations as per the Dhanwantri (HIS) Module of ESIC Project Panchdeep and the First Party shall have the right to seek information from

Dispensary In-charge appointed by Second Party on any prescription or medical certificate issued by it and the same shall be furnished within the stipulated time. The expectation from Modified EUD is annexed at Annexure 'F'.

7.2 The First Party shall have the right to monitor the functioning of Modified EUD through the authorities under the Corporation or Local Committee constituted under Regulation 10A of ESI (General) Regulations, 1950.

8. MEDICAL NEGLIGENCE:

8.1. The First Party shall not be responsible directly or indirectly in cases of Negligence committed on part of the medical staff or doctors appointed by the Second Party working in the Modified EUD.

9. REPRESENTATIONS AND WARRANTIES:

The Parties represents and warrants that:

9.1 The Parties shall have the full power and authority to enter into this Agreement and to perform the acts required of it hereunder;

9.2 The Parties shall comply with all applicable Laws, statutes, ordinances, orders, rules and regulations in operation of the Modified EUD.


10. COMPLIANCE


10.1 Compliance of all the applicable Laws of land including Bio-Medical Waste Management Act, Minimum Wages Act, ESI Act, EPFO, Income tax, GST etc. shall be the responsibility of the Second Party. The Second Party shall ensure due compliance of all labour laws or any other law for the time being in force during the period of setting up, maintenance and running of the Modified EUD.

11. TERMINATION:

11.1 The First/Second Party may terminate this Agreement with or without reason after giving a notice of 60 (sixty days) to the other Party.

11.2. The First Party may terminate this Agreement, with immediate effect, if the Second Party is in breach of any of its obligations, representations or warranties, or any other material terms as contained in this Agreement.

12. DISPUTE RESOLUTION:

12.1. In the event of any dispute or difference arising out or touching to this agreement/contract and/ or in relation to the implementation hereof, the same shall be resolved initially by mutual discussion and conciliation. In the event of failure thereof, the same shall be referred to sole Arbitrator to be appointed by Director General of the Employee State Insurance Corporation (ESIC). The decision of the Sole Arbitrator shall be final and binding upon the parties. The place of the arbitration will be at Delhi and /or where the concerned ESIC Headquarter is situated. The arbitrator shall conduct the arbitration proceedings in English in accordance with the provisions of "The Arbitration and Conciliation Act, 1996. Both the parties know that sole Arbitrator might have dealt with the contract agreement in question and is an employee or officer of Employee State Insurance Corporation (ESIC) but the same shall also not disqualify him in any manner from acting as a sole Arbitrator. In this clause the expression of Director General "Employee State Insurance Corporation" shall also include any person who is for the time being the administrative head of Employee State Insurance Corporation.

13. AMENDMENT:


13.1 This Agreement shall be amended or modified only with the written consent of both the Parties.


14. WAIVER:

15.1 If any term, provision, covenant or restriction of this Agreement is held by a court of competent jurisdiction or other authority to be invalid, void, unenforceable or against its regulatory policy, the remainder of the terms,

16. FORCE MAJEURE:

16.1 Any delay in or failure to perform any obligations by the Parties under this Agreement shall not constitute default hereunder if and to the extent caused by force majeure, which is defined to be occurrences beyond the reasonable control of the Party committing default, including but not limited to acts of the government authorities, acts of God, fire, flood, explosion, riots, war, rebellion, insurrection, sabotage and non-cooperation of third parties.

17. ENTIRE AGREEMENT:

17.1. This Agreement, along with all the schedules and annexure shall constitute the full and complete Agreement between the Parties hereto relating to the subject matter thereof. This Agreement supercedes/cancels all prior communications, understandings and agreements whether written or oral or in electronic form, between the Parties hereto.







e) **Lab Assistant:** certified lab assistant/technician.



RESPONSIBILITIES OF MODIFIED EUD (TO BE SUPERVISED)

1. The dispensary will function at least 6 hours in a day or extended hours as per requirement for 6 days in a week.
2. Subject to the condition prescribed by ESIC, the Medical Practitioner may be authorised to issue the regulation certificates to the Insured Persons for cash benefit.
3. The doctor may also be authorised to scan the duly filled up P-1 referral Form for getting online approval from the ESIS/ESIC Hospitals before referring the entitled beneficiaries for secondary/Tertiary care services from public/private ESIC tie-up hospitals as per the procedure prescribed by the ESIC.
4. Record keeping of all the patients, medicines and services in Dhanwantri (ESIC-HIS).
5. Doctor shall answer in writing, if needed, within a reasonable period as specified by the ESIC Authority or any query raised by the Medical Referee in regard to any prescription or certificate issued by the Medical Practitioner or any statement made in any report furnished by him under these terms of service.
6. Help desk operator will facilitate the beneficiaries to avail benefits of ESIC.
