"GRIEVANCE REDRESS COMMITTEE"

Regulations Governing the Constitution of the Grievance Redress Committee of the University and its Powers and Functions under section 35(viii) & 39 of ACU Act, 2012

1. The Grievance Redress Committee shall consist of the following members:-
 - 1.1. University Students Grievance Redress Committee
 - i. Dean, Academics - Chairperson
 - ii. Director, Students Welfare - Member Secretary
 - iii. Registrar Evaluation- Member
 - iv. Dean of concerned Faculty - Member
 - v. Head of the Institution concerned - Member
 - 1.2. Teaching Faculty Grievance Redress Committee
 - i. The Vice Chancellor- Chairperson
 - ii. Registrar - Member Secretary
 - iii. Dean of Faculty concerned- Member
 - iv. Head of the Institution concerned- Member
 - v. Registrar (Evaluation)- Member
 - 1.3. Non- teaching Faculty Grievance Redress Committee
 - i. The Registrar – Chairperson
 - ii. Head of the Institution concerned - Member
 - iii. Registrar (Evaluation)- Member
 - iv. Finance Officer– Member
 - v. Deputy Registrar - Member Secretary.
2. There will be a Grievance Redress Committee preventing unfair practices and to provide a mechanism to students, parents and others for redressal of their grievances.
3. **Powers & Functions of the Grievance Redress Committee**
 - All the grievances of the students/staff which could not be settled in the routine process should be referred to this committee.
 - Committee tries to settle the issues amicably in a time bound manner.
 - Introduces a reasonable and reliable solution for grievances of various issues received from students/parents
 - Ensures that the grievances are resolved on time impartially and confidentially
4. **Term of the Office**

The term of Office of the nominated members of the Grievance Redress Committee shall be two years and eligible for re-nomination.



5. Admissions of Complaints & Procedure for Redress

- a. Complaints shall ordinarily be sent to the Secretary of the Committee.
- b. As soon as the Secretary receives any complaint seeking redressal of any grievance of the students or research scholars he shall conduct a preliminary enquiry and if he finds it necessary he shall place it before the Committee. The Committee shall then decide whether the complaint shall be entertained or not.
- c. After the Committee has decided that a complaint filed before it should be entertained, it shall commence the enquiry at the appointed time and place or on such other date to which the enquiry may be adjourned.
- d. At the enquiry the oral and documentary evidence on behalf of the complainant shall be presented first and the authorities of the University shall then be given an opportunity to present their oral and documentary evidence. Both the complainant and the authorities of the University shall be allowed to file any supplementary statements in support of their case. After all the evidence is recorded the Committee may, if necessary, allow the parties concerned to argue their case before the committee.
- e. The Committee shall record its findings in respect of the complaint after hearing all the arguments and recording all the evidence.
- f. Based on the findings the Committee shall recommend appropriate action by the concerned authority (ies) for Redressal of the grievance (s).

6. Meeting Procedure:

a. Chairperson of the meeting:

The Chairperson of the Committee shall chair all meetings of the Committee. In the absence of the Chairperson the members present shall elect a Chairperson for the meeting.

b. How matters are decided:

- i. All decisions shall be taken by a simple majority.
- ii. In the event of any conflict the matter shall be referred to the Vice-Chancellor whose decision on the matter shall be final.

c. Minutes of meetings:

- i. The Secretary of the Committee shall be responsible to prepare the minutes of the meeting.
- ii. Every resolution passed by the Committee should be recorded at the meeting and read out by the Chairperson at the meeting itself.



- iii. Within Seven days after the date of the meeting the Secretary of the meeting shall send a copy of the minutes, as approved by the Chairperson of the meeting, all the members of the Committee and to the Constituting Authority.
- iv. The Secretary of the Committee shall submit the proceedings of meeting to the Registrar of University.

d. Record keeping:

The Secretary of the Committee shall maintain all the minutes and other relevant documents related to the functioning of the Committee and shall make these available to any authorized officer/authority of the University for Inspection.

"INTERNAL COMPLAINT COMMITTEE"

Regulations Governing the Constitution of the Internal Complaint Committee of the University and its Powers and Functions under section 35(viii), 39 and 40 of ACU Act, 2012

1. The Internal Complaint Committee shall consist of the following members, namely:-
 - i. Senior Level Women Professor – Presiding Officer
 - ii. One Teaching faculty from each institution – Member (s)
 - iii. Two Non-teaching staff- Member (s)
 - iv. One Student Representative from each institution - Member (s)
 - v. One member from Non-Government organization - Member
 - vi. Deputy Registrar- Member Secretary
2. There shall be Internal Complaint Committee with an inbuilt mechanism for gender sensitization against sexual harassment. Not less than 50% of members should be women
3. **Responsibilities of the Internal Complaint Committee**
 - (a) provide mechanisms of dispute redressal and dialogue to anticipate and address issues through just and fair conciliation without undermining complainant's rights, and minimize the need for purely punitive approaches that lead to further resentment, alienation or violence;
 - (b) protect the safety of the complainant by not divulging the person's identity, and provide the mandatory relief by way of sanctioned leave or relaxation of attendance requirement or transfer to another department or supervisor as required during the pendency of the complaint, or also provide for the transfer of the offender;
 - (c) ensure that victims or witnesses are not victimized or discriminated against while dealing with complaints of sexual harassment; and
 - (d) ensure prohibition of retaliation or adverse action against a covered individual because the employee or the student is engaged in protected activity.
 - (e) provide assistance if an employee or a student chooses to file a complaint with the police;

4. Term of the Office

The term of Office of the nominated members of the Internal Complaint Committee shall be three years and eligible for re-nomination.

5. Meeting:

The Internal Complaint Committee shall meet at least once in six months or more often if necessary.



5.1. Chairperson of the Meeting

The Presiding Officer shall preside over the meeting of the Internal Complaint Committee.

5.2. Quorum

Four members of the Committee including the Chairperson shall form the Quorum

5.3. The process for making complaint and conducting Inquiry -

The ICC shall comply with the procedure prescribed in the Regulations and the Act, for making a complaint and inquiring into the complaint in a time bound manner with required privacy.

5.4. Process of making complaint of sexual harassment -

An aggrieved person is required to submit a written complaint to the ICC within three months from the date of the incident and in case of a series of incidents within a period of three months from the date of the last incident using prescribed Form I. Provided that where such complaint cannot be made in writing, the Presiding Officer or any Member of the Internal Committee shall render all reasonable assistance to the person for making the complaint in writing; Provided further that the ICC may, for the reasons to be accorded in the writing, extend the time limit not exceeding three months, if it is satisfied that the circumstances were such which prevented the person from filing a complaint within the said period." Friends, relatives, Colleagues, Co-students, Psychologist, or any other associate of the victim may file the complaint in situations where the aggrieved person is unable to make a complaint on account of physical or mental incapacity or death.

5.5. Process of conducting Inquiry-

- (i) The ICC shall, upon receipt of the complaint, send one copy of the complaint to the respondent within a period of seven days of such receipt.
- (ii) Upon receipt of the copy of the complaint, the respondent shall file his or her reply to the complaint along with the list of documents, and names and addresses of witnesses within a period of ten days.
- (iii) The inquiry has to be completed within a period of ninety days from the receipt of the complaint. The inquiry report, with recommendations, if any, has to be submitted within ten days from the completion of the inquiry to the Registrar of Adichunchanagiri University. Copy of the findings or recommendations shall also be served on both parties to the complaint.
- (iv) The Registrar shall act on the recommendations of the committee within a period of thirty days from the receipt of the inquiry report, unless an appeal against the findings is filed within that time by either party.
- (v) An appeal against the findings or /recommendations of the ICC may be filed by either party before the Registrar within a period of thirty days from the date of the recommendations.



(vi) If the Registrar decides not to act as per the recommendations of the ICC, then he shall record written reasons for the same to be conveyed to ICC and both the parties to the proceedings. If on the other hand it is decided to act as per the recommendations of the ICC, then a show cause notice, answerable within ten days, shall be served on the party against whom action is decided to be taken. The Registrar shall proceed only after considering the reply or hearing the aggrieved person.

(vii) The aggrieved party may seek conciliation in order to settle the matter. No monetary settlement should be made as a basis of conciliation. The Registrar shall facilitate a conciliation process through ICC, as the case may be, once it is sought. The resolution of the conflict to the full satisfaction of the aggrieved party wherever possible, is preferred to purely punitive intervention.

(viii) The identities of the aggrieved party or victim or the witness or the offender shall not be made public or kept in the public domain especially during the process of the inquiry.

5.6. Interim Redressal: The Registrar may,

- (i) transfer the complainant or the respondent to another section or department to minimize the risks involved in contact or interaction, if such a recommendation is made by the ICC;
- (ii) grant leave to the aggrieved with full protection of status and benefits for a period up to three months;
- (iii) restrain the respondent from reporting on or evaluating the work or performance or tests or examinations of the complainant;
- (iv) ensure that offenders are warned to keep a distance from the aggrieved, and wherever necessary, if there is a definite threat, restrain their entry into the campus;
- (v) take strict measures to provide a conducive environment of safety and protection to the complainant against retaliation and victimisation as a consequence of making a complaint of sexual harassment.

5.7. Punishment and compensation:

- (i) Anyone found guilty of sexual harassment shall be punished in accordance with the service rules of the University, if the offender is an employee.
- (ii) Where the respondent is a student, depending upon the severity of the offence, the Registrar may,-
 - (a) withhold privileges of the student such as access to the library, auditoria, halls of residence, transportation, scholarships, allowances, and identity card;
 - (b) suspend or restrict entry into the campus for a specific period;
 - (c) expel and strike off name from the rolls of the institution, including denial of readmission, if the offence so warrants; and
 - (d) award reformatory punishments like mandatory counseling and, or, performance of community services.



(iii) The aggrieved person is entitled to the payment of compensation. The Registrar shall issue direction for payment of the compensation recommended by the ICC and accepted by the Board of Management, which shall be recovered from the offender. The compensation payable shall be determined on the basis of-

- (a) mental trauma, pain, suffering and distress caused to the aggrieved person;
- (b) the loss of career opportunity due to the incident of sexual harassment;
- (c) the medical expenses incurred by the victim for physical, psychiatric treatment;
- (d) the income and status of the alleged perpetrator and victim; and
- (e) the feasibility of such payment in lump sum or in installments.

5.8. Action against frivolous complaint:

To ensure that the provisions for the protection of employees and students from sexual harassment do not get misused, provisions against false or malicious complaints have to be made and publicized. If the ICC concludes that the allegations made were false, malicious or the complaint was made knowing it to be untrue, or forged or misleading information has been provided during the inquiry, the complainant shall be liable to be punished as per the provisions of sub-regulations (i) of regulations 5.7, if the complainant happens to be an employee and as per sub-regulation (ii) of that regulation, if the complainant happens to be a student. However, the mere inability to substantiate a complaint or provide adequate proof will not attract attention against the complainant. Malicious intent on the part of the complainant shall not be established without an inquiry, in accordance with the procedure prescribed, conducted before any action is recommended.

5.9. Right to appeal

In case of disciplinary actions by the University against its employee or student, the aggrieved employee or students shall have a right to appeal to Hon'ble Chancellor or Vice Chancellor.

- (1) Any person, whether employee, student or volunteer, in any experiment station, bureau, laboratory, research facility, or other facility of the university or with funding, equipment, or infrastructure provided by or through the university.
- (2) An employee of the university acting within the scope of his or her employment, regardless of the location of the research or the nature of the funding, equipment or infrastructure used.

Any such discovery, invention or patent shall be defined as “Adichunchanagiri University invention.”

4.0 ACU-Patent Scrutiny Committee

The Patent Scrutiny Committee (PSC), will be the leading administrative body, headed by Hon’ble Vice Chancellor shall oversee and guide the processing and management of the ACU’s patents, including its commercialization. The PSC is responsible for critically reviewing and interpreting the patent to be filed and for resolving any dispute that may arise in the context of patents and inventor (s) at the ACU in due course.

The members of Patent Scrutiny Committee include **Vice Chancellor as Chairperson, Pro Vice Chancellor / Dean Research as Vice Chairperson, Chief Coordinator, ACU-IPR Cell as Members Secretary and *three external experts*** drawn from different disciplines such as Science, Engineering, and Life Sciences & Health Sciences. These external members are the well-established leaders in their respective field with a vast research experience working in reputed institutions in India. Besides, the Vice Chancellor can nominate *one Legal Expert* for legal inputs. A legal declaration on “Non-Disclosure Agreement” and “Conflict of Interest” may be sought from the external members of the patent scrutiny committee before nominating them to the said committee.

The PSC can be as follows:

The function of Patent Scrutiny Committee would be the following:

- (a) To review new inventions for possible patent filing based on criteria established by Indian/International/United states patent law.
- (b) To examine the authenticity of the patent applications in order to regulate the monetary expenses involved in patent filing and to prevent the loss of money if the patents are not granted after they are filed.
- (c) To check whether the inventor(s) have established standard operating procedure (SOP) for the invention and subsequent academic and social impact of the patent to be filed.
- (d) To assess the quality, authenticity, plagiarism (from any thesis/dissertation/project work, etc.,) and probability of the acceptance (by the patent authority) of the patent to be filed.
- (e) Verification of the log books, laboratory records, computer files, data sets, images and figures etc., pertaining to the patent to be filed.
- (f) Verifying the involvement of each inventor as a part of science ethics.
- (g) PSC shall call the Inventor(s) for 15 to 20 minutes presentation about the invention for substantiating the commercial value and potential industries interest in this invention.
- (h) ACU needs to empanel leading Patent Attorneys, and any one of them can be assigned the responsibility to file the patent recommended by PSC.

The time line for the processing the application shall be followed as per Annexure 1.

Fast Track Process: If the inventor(s) is not in a position to wait for the IPR Cell to process the documents as per the Annexure 1, then the Inventor(s) may proceed with provisional or non-provisional with complete specifications of patent through the ACU panel of attorney, provided the Inventor(s) can pay for the filing of patent. The inventor(s) can request the IPR Cell to review the invention as per the ACU guidelines, and if PSC recommends the invention is worthy, then the cost of filing borne by the inventor(s) can be reimbursed.

5.0 Research and Innovation (R&I): Categories of and Ownership of Patent

The ownership of all patents developed by the ACU personnel in the course of or pursuant to Research and innovation at the University, with substantial utilisation of university resources vests with ACU. As an exception, joint ownership of patent with the Sponsor/ Funding Agency/ Industry will be considered under following circumstances:

1. Preamble

Publication Guidelines & Monitoring Committee demonstrates the commitment of Adichunchanagiri University to promote high ethical standards in academic publications of the students, faculty members and researchers of the Adichunchanagiri University (ACU). This committee will also play an advisory role to facilitate compliance to essential ethical practices to all concerned in publications throughout the Adichunchanagiri University.

The objective of the Publication Guidelines Committee is to ensure quality and ethical practice of all the submitted academic publications in accordance with the ICMR and international ethical guidelines for publications.

2. Guidelines

- Publication Guidelines & Monitoring Committee shall follow the recommended national and international best practices as mentioned below for scrutiny and approval of manuscripts of publications:
 - Indian Council of Medical Research. Ethical Guidelines for Biomedical Research on Human Subjects. New Delhi : 2006 (Page number:32-33)
 - Uniform Requirements for Manuscripts Submitted to Biomedical Journals: Writing and Editing for Biomedical Publication. Updated April 2010; Details regarding the Publication Ethics: Sponsorship, Authorship, and accountability; International Committee of Medical Journal Editors is given at (www.icmje.org).
- The corresponding author will be responsible for the submission of necessary documents and follow the guidance till the stage of final approval. All scientific writings [research, case report, review, etc] which involve resources of the institute should be subjected to the process of PGC. The corresponding author shall usually be the faculty who is the supervisor of the researcher/student or the faculty who designed and took lead in data collection and analysis. In circumstances where the student who designed the study and conducted the study has left the institution and showed no interest to publish the work, the Supervisor/Guide of the Department concerned can take up the responsibility of publishing the work as corresponding author.
- The first author of the submitted work should be the researcher/student/faculty in whose name ethics approval is obtained and who has actually conducted the study[or] the lead person who did the study (for research which do not require ethics approval).

- Authorship can be given to other collaborators/investigators who have participated in the conduct of the study and the order of authorship can be decided by the primary researcher/student/faculty and the supervisor/Head of the department.
- Required Documents for successful fast-track clearance by PGC:
 - The corresponding author should upload the manuscript for plagiarism check through the portal webpage through the PGC/faculty link as per the norms and guidelines provided in the UGC (Plagiarism) Regulations -2018.
 - On receipt of the plagiarism report assessed by the software DRILBIT, the author should see if the percentage is $> 15\%$ including references of the manuscript. If so, the author shall re-write the highlighted plagiarized phrases and resubmit at portal for re-assessment. Once the plagiarism percentage of $<15\%$ is reached, the corresponding author can proceed to next step.
- The corresponding author should submit the following documents.
 1. Letter to PGC Chairperson forwarded by Head of Department / Guide cum Supervisor.
 2. Letter of undertaking from all the authors from Adichunchanagiri University.
 3. Copy of plagiarism report.
 4. Manuscript in word format which follows the respective journal house of style.
 5. Ethical Clearance Letter to be submitted for the publication from a research project (biomedical research, animal research and clinical trials).
 6. For studies based on information on health records of Adichunchanagiri University (medical records, laboratory registries, outpatient registries, etc.) prior permission should have been obtained from Medical Director/Chief Operating Officer/Dean of the Medical College/Medical Superintend before initiating data collection. A copy of the approval letter should be enclosed.
- Upon submission, the above-mentioned documents will be scrutinized by the concerned PGC member who will then approve/ suggest revision of the manuscript.
- Once approved by PGC member, the submission file moves to the final approval by PGC Chairperson.
- The authors are advised to submit their manuscript to Journals indexed in SCOPUS/PubMed/Web of Sciences/ UGC approved list of journals.
