Treadmill Test (TMT) MACHINE WITH ECG ANALYSIS SYSTEM

- 1. The Treadmill Stress Test System should be complete with acquisition of resting and stress ECG, Treadmill Unit with interface with all the protocols and provision of printing the resting as well as stress ECG and analysing the same.
- 2. Should acquire and analyse 12/15 simultaneous ECG Leads and display of all 12/15 leads real time Rhythm ECG on screen.
- 3. Should have facility of on line storage of patient ECG data. Storage patients on HDD. In addition, the storage on CD/DVD should be possible.
- 4. The monitor should display auto comparison of resting versus current lead of maximum ST depression separately with colour coded protocol, stage, clocks for elapsed time, total time, Target HR, Treadmill speed & grade, PVC counts/minute, warning messages & prompts, lead check torso.
