SECTION -I

Instruction to Tenderers

14. The Tenderer shall send quotes in **2 bid formats (Technical and Financial bids sealed separately inside the main envelope for any or all list of items)** on professional business letterheads. The inner and outer sealed cover must bear the following identification

3. Address to “The Registrar, Adichunchanagiri University, B.G. Nagara -571448, Nagamangala (T), Mandya (D)”
4. The tenderer who prefers to submit the tender through Post can dispatch the same through Registered Post / Speed Post or Courier so as to reach the above address on or before the due date and time specified in the Tender Notice. Tenders received after the due date and time, for what so ever reasons will not be considered and the authority, ACU BG-Nagara will not be liable or responsible for the same.

15. **Tender Currency:** Prices shall be quoted in Indian Rupees Only

16. **AMC/CMC (If any)** is subject to the Adichunchanagiri University’s norms.

17. **Warranty:** As per the Standard, preferably 03 years



18. **Amendment of Tender Documents:** At any time prior to the deadline for submission of tenders, the University may, for any reason, whether at its own initiative or otherwise, modify the tender documents by amendment. Adichunchanagiri University reserves all the rights to accept, reject, incorporate changes and re-tender without giving any reasons.
19. **Documents Comprising the Tender:** Shall attach Brochure, Certification of the product, Bank/account details, PAN, GSTIN, Good Standing Certificate and 02 Years of ITR declaration inside the envelope and company contact details with email ID on the main envelope cover for further correspondence.
20. **Tender Prices:** Prices indicated on the Price Schedule shall be entered separately I.e. the price of the goods, quoted (ex-works, ex-factory, ex-showroom, ex-warehouse, or off-the-shelf, as applicable), including all duties and sales and other taxes already paid or payable. Any Indian duties, sales and other taxes which will be payable on the goods if this Contract is awarded. Conditional tenders will not be considered.
21. **Validity of the Bid:** 90 Days from the last date of submission of bid
22. **Corrupt or Fraudulent practices:** The Adichunchanagiri University requires that the Tenderers, observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy:
3. will reject a proposal for award if it determines that the Tenderer recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question;
 4. will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a university contract if it at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing, a University contract.
23. **Process to be confidential:** Information relating to the examination, clarification, evaluation, and comparison of Tenders and recommendations for the award of a contract shall not be disclosed to Tenderers or any other persons not officially concerned with such process until the award to the successful Tenderer has been announced. Any effort by a Tenderer to influence the Employer's processing of Tenders or award decisions may result in the rejection of his Tender.
24. **Clarification of Tenders:** To assist in the examination, evaluation, and comparison of Tenders, the Employer may, at his discretion, ask any Tenderer for clarification of his Tender, including breakdowns of unit rates. The request for clarification and the response shall be in writing or by cable, but no change in the price or substance of the Tender shall be sought, offered, or permitted except as required to confirm the correction of arithmetic errors discovered by the Employer in the evaluation of the tenders.

26. Penalty Clause: Non-execution of supply order - For the reasons of failure to supply partially or completely within the stipulated time or any event of breach of contract. In case at any following stages

1. For the delayed supply (3 days of grace period) - 5% deduction
2. Quantity issues - 5% deduction
3. Quality issues - 10% deduction

Detailed specification requirement for a Bench top Microscope with Display Head

Requirements

Microscope Specifications

1. Type

- The microscope must be an upright bright field analogue benchtop model with research-grade internal optics.

2. Objectives

- The microscope must include four premium high contrast infinity corrected plan achromate objective lenses: 4X, 10X, 40X and 100X oil immersion
- Internal magnification must be 10X with FN 20

3. Focusing System

- The microscope must feature a low position coaxial coarse and fine focusing system
- Coarse focusing travel range must be 25mm
- Fine focusing travel range must be 2m/division.
- The microscope must have a large size double layer mechanical stage measuring 216X150mm
- Moving range of the stage must be 75mmX55mm

4. Condenser

- The microscope must have an Abbe condenser with N.A. 1.25.
- The Condenser must include an iris diaphragm and be Center adjustable with a filter holder

5. Light Source



- The microscope must feature Kohler illumination
- The Light source must be a 3W/LED with adjustable brightness.

Digital Display Head Specifications

4. Display Unit

- The digital display head must include an 11-inch display
- The display must operate on iOS
- The display must feature a 12MP camera
- The display must be Wi-Fi Only.
- The display must have 64GB storage capacity.

5. Apple Pencil/Stylus

- The system must include a 2nd Generation apple pencil/Stylus

6. HDMI Projection Dongle

- The System must include an HDMI projection dongle with connectors compatible with display unit

Additional Requirements

3. Warranty

- The microscope must come with a standard warranty of 1 year.
- Extended warranty options must be available for up to 3 years for the microscope.
- The display unit and accessories must come with a standard
- Extended warranty options must be available for up to 2 years for the display unit

4. Connectivity

- The microscope system must allow for easy connection to external displays and projectors through the HDMI projection dongle
