- 1) The Tenderer shall submit the bids (Technical & Financial bids) through the mail id: clpcheadtender@bgscet.ac.in on or before the last date of tender submission (for any or all list of items) on professional business letterheads only. The details to be printed on the letter head is as follows

 - iv) The tenderer shall submit the original documents to this office on the last day of submission for verification who prefers to submit the tender through Post can dispatch the same through Registered post / Speed post or Couriers as to reach the above address on or before the due date and time specified in the Tender Notice. Tenders received after the due date and time, for what so ever reasons will not be considered and the authority, Head of CLPC will not be liable or responsible for the same.
- 2) **Tender Currency:** Prices shall be quoted in Indian Rupees only.
- 3) **AMC/CMC (IF ANY)** is subject to the Sri Adichunchanagiri shikshana trust's norms.
- 4) **Warranty:** 3 Years.
- 5) **Amendment of tender documents:** At any time prior to the deadline of submission of tenders the trust may, for no reason, whether as its own initiative or otherwise modify the tender

documents by amendment. Sri Adichunchanagiri Shikshana Trust reserves all the rights to accept, reject, incorporate changes and re-tender without giving any reasons.

- 6) **Documents Comprising the Tender:** Shall attach Brochure, Certification of the product, Bank/account details, PAN, GSTIN, Good Standing Certificate and 02 years of ITR declaration inside the envelope and the company contact details with email id on the in the below mention format in annexure - 1.
- 7) **Tender Prices:** Prices indicated on the price schedule shall be entered separately I.e. the price of the goods, quoted (ex-works, ex-factory, ex-showroom, ex-warehouse, or off-the-shelf, as applicable), including all duties and sales and the other taxes already paid or payable. Any Indian duties, sales and other taxes which will be payable on the goods if the contract is awarded. Conditional tenders will not be considered. The bidder has to give the quotation in the below enclosed format in annexure - 2.
- 8) **Validity of the Bid:** 90 days from the last date of submission of bid.
- 9) **Corrupt or Fraudulent practices:** Sri Adichunchanagiri Shikshana Trust requires that the tenderers, observe the highest standard of ethics during the procurement and execution of such contracts. In purchase of this policy:
 - a) Will reject a proposal for award if it determines the tenderer recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question;
 - b) Will declare a firm ineligible, either indefinitely or for the stated period of time, to be awarded a university contract if it any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing, a trust contract.
- 10) **Process to be confidential:** Information relating to the examination, clarification, evaluation, and comparison of tenders and recommendations for the award of contract will not be disclosed to tenderers or any other persons not officially concerned with such process until the award to the successful tenderer has been announced. Any effort by a tenderer to influence the employer's processing of tenders or award decisions may result in rejection of his tender.
- 11) **Clarification of Tenders:** To assist in the examination, evaluation, and comparison of tenders the employer may, at his discretion, ask and tenderer for clarification of his tender, including breakdowns of unit rates. The request for clarification and the response shall be writing or by cable, but no change in the price or substance of the tender shall be sought, offered, or permitted except as required to confirm the correction of arithmetic errors discovered by the employers in the evaluation of the tenders.

- 13) **Penalty Clause:** Non-execution of supply order – for the reasons of failure to supply partially or completely within the stipulated time or any event of breach of contract. In case at any following stages
 - a) For the delayed supply (3 days of grace period) – 5% deduction
 - b) Quantity issues – 5 % deduction
 - c) Quality issues – 10% deduction

1. Surgeon Gown – 330 Pairs

TECHNICAL SPECIFICATION

Reusable Surgeon Gown (Operation Theatre Use)

1. General Description

Reusable surgical gown suitable for use in Operation Theatre (OT), designed to provide **barrier protection, comfort, and durability** for repeated use after washing and sterilization.

2. Fabric Specification (Most Important Section)

The gown shall be made from high-quality, tightly woven fabric with the following properties:

- **Material Composition:**
 - Polyester-Cotton blend (65:35 or 70:30) OR
 - 100% cotton casement fabric (premium grade)
- **Fabric Weight (GSM):**
 - Minimum 180 GSM to 220 GSM
- **Weave Type:**
 - Tight plain weave / casement weave to reduce lint and microbial penetration
- **Finish:**
 - Pre-shrunk, colorfast, and anti-lint treated
- **Fluid Resistance:**
 - Must provide **moderate fluid repellency**
 - Reinforced / laminated panel at **chest and sleeves (critical zone)** preferred
- **Breathability:**
 - Fabric should allow air permeability for long surgical comfort

3. Design & Construction

- Full-length gown (knee/ankle length)
- Full sleeves with:
 - Knitted cuffs / elastic cuffs for secure fit
- Neck:
 - Round neck with tie / Velcro closure
- Back:
 - Full overlap / wrap-around design for maximum coverage
- Waist:
 - Tie belts at back
- Stitching:
 - Double stitched seams for durability
- Reinforcement:
 - Double layer or impermeable fabric in:
 - Chest area
 - Sleeve front

**4. Performance Requirements**

- **Reusable Cycles:**
 - Minimum 100-150 wash cycles without degradation
- **Sterilization Compatibility:**
 - Suitable for:
 - Autoclaving (121°C)
 - ETO sterilization
- **Shrinkage:**
 - ≤ 3%
- **Color Fastness:**
 - Resistant to repeated washing and disinfectants
- **Lint Control:**
 - Low linting to reduce infection risk

5. Protection Standards

- Should comply with:
 - AAMI PB70 Level 2 or Level 3 (minimum recommended)
 - OR equivalent international standards (EN 13795)
- Must provide protection against:
 - Blood and body fluids
 - Microbial penetration

6. Sizes & Color

- **Sizes:**
 - Standard (Free Size) / M, L, XL, XXL
- **Color:**
 - OT Green / Blue (non-reflective) – To be select

7. Additional Features

- Breathable and lightweight for long surgeries
- Skin-friendly and non-irritant fabric
- Anti-static and anti-microbial finish (preferred)
- Label indicating:
 - Manufacturer name
 - Batch number
 - Wash instructions

8. Packing

- Individually packed or in bulk
- Sterile / non-sterile (as required)
- Proper labeling

- Sample must be approved before bulk supply
- Fabric test report (GSM, composition)
- Wash test certificate (minimum cycles)
- Compliance certificate for medical textile standards

2. Patient Gown – 250 Pairs**General Description**

Reusable patient gown suitable for use in **Operation Theatres (OT), Intensive Care Units (ICU), wards, and diagnostic areas**. The gown shall ensure **patient comfort, dignity, infection control, and durability** under repeated washing and sterilization.

2. Fabric Specification

- **Material:** 100% Cotton / Poly-Cotton Blend (preferred 60:40 or 50:50)
- **Fabric Type:** Woven, breathable, soft finish
- **GSM:** 120–180 GSM (minimum 120 GSM for durability)
- **Properties:**
 - Breathable and skin-friendly
 - Hypoallergenic and non-irritant
 - High absorbency (for patient comfort)
 - Low lint / minimal fiber shedding
- **Optional Treatment:**
 - Antimicrobial finish (preferred for ICU use)
 - Colorfast, shrink-resistant

3. Design & Construction

- **Type:** Back-open / Overlap design
- **Closure:** Adjustable tie system (minimum 3–4 ties at back/side)
- **Neck:** Round / V-neck
- **Sleeves:** Half sleeve or short sleeve (ICU/OT compatible)
- **Length:** To be decide
- **Fit:** Free size / Multiple sizes (M, L, XL, XXL) to be select

- **Coverage:** Full body coverage ensuring patient dignity
- **Stitching:**
 - Double-stitched seams for strength
 - Reinforced stress points

4. Functional Requirements

- Easy to wear/remove for bedridden patients
- Allows access for medical procedures (IV lines, monitoring, etc.)
- Comfortable for prolonged wear in ICU
- Suitable for both male & female (unisex design)
- Should not restrict movement

5. Barrier & Safety Requirements

- Moderate fluid resistance (not fully waterproof)
- Should withstand exposure to body fluids
- Fabric must maintain integrity after multiple washes
- Non-toxic dyes and finishes

6. Laundering & Reusability

- **Washable:** Minimum 200-300 wash cycles
- **Sterilization Compatibility:**
 - Autoclave safe (121°C)
 - Resistant to hospital disinfectants (e.g., chlorine 0.5%)
- **Shrinkage:** ≤ 3% after washing

7. Color & Identification

- Standard hospital colors: Light Blue / Green / Printed checks or to be select
- Color-coded options for departments (optional)
- Should retain color after repeated washing



8. Packaging

- Individually packed or in bulk (as per tender requirement)
- Proper labeling with:
 - Manufacturer name
 - Fabric composition
 - Size
 - Batch number

9. Compliance & Standards

- Should comply with:
 - ISO / BIS standards for hospital textiles (if applicable)
 - Infection control guidelines
- Manufacturer must have:
 - Quality certification (ISO 9001 preferred)

- Sample approval before bulk supply
- Random quality inspection during supply
- Stitching, size, and finishing must meet specifications

Big Hole Towel (Reusable Surgical Towel)

2. Intended Use:

Used in Operation Theatres (OT) for surgical procedures to isolate operative area with central opening.

3. Fabric Quality:

- High-quality reusable fabric
- Material: 100% Cotton / Cotton-rich blend
- Soft, absorbent, lint-free, and breathable
- Non-irritant and skin-friendly

4. Fabric Weight (GSM): Minimum 180–220 GSM**5. Size:**

- Standard Size: Approx. 75 cm × 90 cm (or as required)
- Central Hole Diameter: 8–12 cm (customizable as per requirement)

6. Stitching:

- Double-stitched edges for durability
- Reinforced stitching around central hole
